Ian Howard from Wellesley contributes an article in each of our quarterly newsletters in which he provides his views on the changing financial landscape and the potential effects on our finances. So please read on.....

As the UK prepares to welcome a new tax year this 6th of April, Jeremy Hunt presented to Parliament a wide range of benefit reforms and tax reductions in his 2024 Spring statement. Let's delve into what these could mean for you and your money.

#### Spring Budget 2024: The Highlights

Millions of workers stand to benefit from a decrease in National Insurance Contribution, with employed individuals set to receive a cut from 10% to 8%, and self-employed workers from 8% to 6%. This is in addition to the 2% cut announced in the 2023 Autumn Statement, which came into effect on 6th January with this further reduction coming into effect in April 2024. However, personal tax thresholds remain frozen until April 2028, which will still see an increase in payments for many households.

The chancellor further announced a new stocks and shares ISA which is currently in its consultation phase. The British ISA will enable savers to further allocate £5,000 allowance for investment in UK equities. This will be in addition to the current £20,000 annual allowance already available with other ISA products. In addition to this, the government will allow multiple subscriptions to ISAs of the same type every year from April 2024, as of 2023's Autumn Budget.

Despite speculations preceding the latest statement, Inheritance Tax (IHT) remains unchanged, and Capital Gains Tax (CGT) retains its existing framework, except for a significant change concerning gains from non-exempt residential properties.

The Spring Budget, with its challenges, sees favorable reforms for many, but what developments can we expect for your pensions in the upcoming tax year?

#### Navigating Pensions in April 2024

Although the annual allowance will remain at £60,000, pensioners are set to receive an impressive 8.5% boost in their State Pension from 8th of April. This stems from the government's commitment to maintaining the State Pension triple lock which ensures that income does not lose value over time.

As part of the ongoing initiatives to stimulate investment in UK Equities, the Chancellor introduced new reporting rules, requiring pension providers to publicly disclose where their funds are invested, and how they have performed.

As we look back to last year's Spring budget, those with substantial pension savings will benefit from the abolishment of the Lifetime Allowance this upcoming 6th April 2024.

Whilst the Treasury's Spring Budget 2024 saw no further changes in the world of pensions, it goes without saying that the new tax reductions and pension reforms from previous Budgets will have a notable impact.

#### **Global Perspectives**

Ongoing geopolitical tensions have had limited implications on international performance, however, the upcoming US election scheduled for later in the year may have a more significant impact on global markets.

The constantly evolving economic landscapes and taxation policies make it even more crucial to plan ahead, stay informed and be proactive in managing your finances.
